

Airedale NHS Trust Maternity Services – Ockenden Report Update

Background



The Ockenden with review was in response to a number of concerns regarding the poor standard of care at Shrewsbury and Telford. This resulted in the death of babies and mothers.

Following the publication of the review in December 2020, NHS England and NHS Improvement have challenged NHS providers commissioners and local maternity services to review the existing insurance mechanisms to ensure they safe and effective.

The emerging findings and themes formed seven early recommendations, identified as Immediate and Essential Actions (IEA) followed by 12 urgent clinical priorities. Each urgent clinical priority has it's own assurance and assessment requirement for reporting and evidencing the actions.

This is Airedale's response to the 12 Urgent Clinical Priorities, broken down by IEAs.



Immediate Assurance Actions (IEA's)

Managing Complex Pregnancy	Yes	 a) All women have named consultant – complex pregnancy lead b) Maternal Medicine Centre - referral to tertiary centres being agreed
Risk Assessment	Yes	 a) Risk Assessment recorded at booking – Systmone templates being updated b) Development of Personalised Choice App and AireMid App
Fetal Monitoring Lead	Yes	a) Obstetric and Midwifery Lead roles being developed
Informed Consent	Yes	a) New platform and re-design of Website ongoing

 Patient experience shared at Board, "You Said We Did" boards.
 Feedback from 15 steps and inclusion of MVP. MVP attendance at
 workshops including induction of labour.
- Open and Transparent NHS E invited to attend the maternity unit to provide external peer review in 2019 and has structured the QI planning.

Next Steps....



- Embed Ockenden Audits and monitor compliance
- Perinatal Quality Surveillance Dashboard monthly to board
- Introduction of a local perinatal surveillance group to share/review any safety concerns following incident reporting/HSIB referred cases.
- Await further National guidance on recommendations. ANHST will comply once agreed.
- Introduction of Independent Advocate role role to be agreed.
- New platform for re-design of My Pregnancy Journey & Maternity website
- Introduction of Personalised Choice App
- Continue to strengthen and build on relationships with MVP
